Plastic bag ordinance went through – starts July 1. 10 cents for plastic or paper bag. Free bags starting the month before.

Free compost – hoping to get bill passed this year. Implementation is a slow rollout. We own all trucks and bins so would need to purchase more.

Shawnda – will there be smaller trucks for alleys? Maggie – This would go over to enterprise fund so can bond off of future revenue of that program.

Dave – recycling? Maggie – we have "wishful" recycling in Denver. Biggest problem: putting it into plastic bag then into bin. Don't do this!!

Gloria – who regulates requirements under short term rental? Maggie - Excise License. Gloria – they need to make sure short-term rentals tell renters the rules.

Gertie – squirrels have gotten into her compost bin. Maggie: City will provide you a new bin – just contact them.

**Scott Balderman** – new school board member District 1. Wants to come to more of these meetings and relay info back to DPS.

Went to meeting about new things happening in Harvard Gulch and Platt Park re schools.

Sarah – would love to see school board pass policy that they never sell a piece of land again. We are stewards of public property and now owners. If we sell more property will never get it back.





1. Land Use and Transportation – Shawnda – 2 months ago had meeting at Country Club Towers – wanted to know about concerns re Alameda and Downing.

PW studied Alameda corridor in 2017 due to serious accidents. PW has new plan to study again to improve safety. Knowing this, we went out to ask neighbors about their concerns.

Wanted to get letter out before analyzing starts (Feb).

Shawnda wants the letter to be approved by the WWPNA board to put leverage behind it. Sherri wants to work with Shawnda on the letter before approving.

### 2. Zoning Committee

Committee hasn't met since Sept due to weather (Oct and Nov) and holiday cancellations.

#### Old Business:

450 N Broadway Sukiya: Hotel and Restaurant liquor license hearing Nov 17. 9:00 AM

Chris Miller and Gertie Grant attended the hearing. Gertie represented WWPNA AND BHNA (she is a member of BHNA also) and Chris testified in support of the applicant. GNA was admitted into evidence. Excise and License approved the 4 conditions on the license from the GNA but declined to add a term that both parties agreed to have on the license that specifically said the 4 terms were to travel with the license.

## **Ongoing business:**

240 S Pennsylvania case 175-19 hearing moved second time to Feb 25, 2020 11:00 AM: Applicant: Joshua and Katherine Gotter (owners of 254 S Penn). Appeal for Review of an Administrative Decision to suspend rather than revoke a previously issued fence permit in an R-2 zone district. Appellant's amended statement is almost as long as the first (50 pages long including attachments). Dispute is over the southwest corner of 240 S Penn and whether some kind of easement was granted when alley on north side of 254 was vacated in 2008. Mark Harris did an excellent job getting both sides of the conflict before official appeal received. Email discussion among Zoning committee members are that we should not take a position in this case.

## MOTION FOR THE WWPNA BOARD:

That WWPNA abstain from taking a position on this matter for the following reasons:

- The property in question borders the alley behind 240 S Pennsylvania, is not visible from the street and does not impact the public realm;
- This is an issue between two neighboring properties on the interior of the block;
- Due to the unique facts of this case, it does not set a precedent for the neighborhood.

### 12 votes by board to abstain from taking position

**864-868 S Pearl**: owner of 2 multi-unit buildings would like to replace them but needs to combine the parcels and rezone. Owner Jennifer Miller and her consultant met with 4 near neighbors but had no plans. This was to be the topic of discussion at the Oct 29<sup>th</sup> and Nov meeting which was cancelled due to snow/cold. Sarah McCarthy and Linda Fabrizio handling.

### New business:

**Marlan** asking re house near him with very large deck – wondering when city allowed this to happen. Gertie said to call 311 inspections to see if in compliance. Things changed in 2010 that have negatively affected the neighborhood.

Shawnda – when call, get reference number and demand to speak with neighborhood inspector.
